(SETAS)**

I, Bonginkosi Emmanuel Nzimande, Minister of Higher Education and Training, after consultation with the National Skills Authority, has under section 9A of the Skills Development Act, 1998 hereby determine the 1st of April 2011 for the Sector Education and Training Authorities (SETAs) as set out in schedule 1 to amalgamate and to have jurisdiction as indicated in schedule 2.

SETA 04: The Clothing, Textiles, Footwear and Leather Sector Education (CTFLSETA) and Training Authority, **SETA 10:** Forest Industries Education and Training Authority (FIETA) and specific sub sectors of **SETA 15:** Media, Advertising, Publishing, Printing and Packaging Education and Training Authority (MAPPP) shall be amalgamated on the 1st of April 2011 to become a Fibre Processing Manufacturing Sector Education and Training Authority subject to the approval of a constitution and confirmation of the Scope of Coverage for the amalgamated SETA.
