Bidders are advised that their proposal should be comprehensive, concise, written in plain English, legible and simply presented. The proposal should include:

Description of current infrastructure arrangements (Organisational structure, equipment and systems);

Original and Valid Tax clearance certificate;

Company registration documents;

Original or certified BBBEE certificate.

### Price/Financial Proposal – One original and three copies

Proposed total budget including vat;

Costs per deliverable.

Consortium/Joint Ventures must submit their consolidated tax clearance certificates.

#### 1. Introduction and Background

- 1.1. The Fibre Processing and Manufacturing (FP&M) SETA was established by the Minister of Higher Education and Training on 01 April 2011 to 31 March 2016. The FP&M SETA (SETA) is a result of the amalgamation of the CTFL SETA, FIETA and the Printing, Packaging and Publishing sectors of the MAPPP SETA. The FP&M SETA facilitates skills development in the following sub sectors: Clothing, Footwear, Forestry, Furniture, General Goods, Leather, Packaging, Print Media, Printing, Publishing, Pulp and Paper, Textile and Wood. The FP&M SETA's operations license has been renewed for another two years from 1 April 2016 31 March 2018.
- **1.2.** The FP&M SETA vision is to become a "credible and effective skills development partner" to its stakeholders in the FP&M sub-sector and to be recognized nationally for its service excellence.
- 1.3. FP&M SETA is mandated to implement the objectives of the National Skills Development Strategy III and to ensure that both the employed and unemployed are upskilled to address the scarce and critical skills priorities to build the capacity of the sector to become economically sustainable and globally competitive in the medium to long term.

#### 2. Project Purpose

- **2.1.** The FP&M SETA requires the service of a suitable and qualified ISP to offer a comprehensive and robust internet solution to the FP&M SETA
- 2.2. The FP&M SETA has offices in Johannesburg "Braamfontein", Durban "Pinetown" and Cape Town "Woodstock" and requires these sites to function as a single entity even though they are in different locations. Furthermore, FP&M SETA's business critical systems such as AX, indicium, share point etc, are host and located at the I-net Bridge, therefore we also need a dedicated link to the I-net bridge offices.
- **2.3.** FP&M SETA requires a robust and fault-tolerant internet solution that will link these fours sites' IT infrastructures over a WAN" Wide Area Network" connections. The solution should be provided, monitored, and maintained by the successful applicant.

#### 3. Scope of Service

- 3.1 The internet solution should make it possible for FP&M SETA to archive the following:
  - Allow the users at the sites to access and share data amongst each other;
  - Facilitate server communication between sites;
  - Allow the sites to use video conferencing equipment to communicate with each other over the WAN links. The VC equipment requires a minimum of 1MB dedicated connection, up and down (quality of service is a requirement);
  - Provide the sites with centrally monitored access to the internet over the WAN links by means of a hosted and managed firewall;
  - Firewall needs to cater for reporting requirement that can drill down to granular levels such as source IP and destination IP;
  - As part of the firewall comprehensive reporting, system must produce near real-time visual;
  - All internet solutions equipment must be new from the manufacturer and must qualify for warranty;
  - Allow the three sites to be able to receive external video conferencing calls from other organizations over the internet;
  - The connectivity links should provision for the three FP&M SETA sites "JHB, DBN and CPT" to make telephone calls between each other, should the SETA decided to implement VIOP telephone solution;
  - Provide a spam filtering and archiving solution for all mails coming into and going out of our organization's mail server;
  - FP&M SETA might also be migrating from onsite exchange 2013 to office 365, therefore the solution should also cater for the possibility of this requirement;
  - Provide a hosting facility\ 9U rack space where our mail server, Lynch server, DC, and application server can be accessed centrally by the three sites. Note all these servers will be working as virtual server on a single DL 360 server with hyper V. The DL 360 server will be connected to a storage server and a Symantec 3600 essential back up device;
  - The WAN link should allow for the QOS "quality of service" as will be determined by FP&M SETA;
  - The solution should have wireless failover capabilities that will ensure 100 % uptime of connectivity.

 Any maintenance that might affect the solution thereby impacting on the FP&M SETAs business operation, should be communicated at least one (1) week in advance and FP&M SETA should accept or acknowledge the maintenance and downtime.

#### 4. Eligible Costs

The funds allocated under these bid specifications are not intended to finance infrastructure and/or ongoing operational costs of the applicant's organization to be able to deliver on this project. For this reason, only applicants who can demonstrate that the required infrastructure is in place should apply, as only costs directly related to the delivery of the project will be covered.

#### 5. Reporting Framework and Scheduling

- **5.1** The successful applicant will report to the FP&M SETA **IT Manager** for the agreed timeframes in terms of the delivery schedule for the project.
- **5.2** The Service provider must and shall be required to:
  - Provide the IT team with training on the systems to perform basic tasks and read access to the firewall and other important systems;
  - Report all connectivity lines to any third party services provider...e.g. (Telkom, MTN, Vodacom, etc);
  - Monitor, maintain and report connectivity issues to ensure maximum uptime;
  - Provide professional advice on which connectivity packages are most suitable and cost effective for the organization;
  - Ensure that all people working with the connectivity issues are well trained and equipped to deal with the network connectivity issues that will be reported /monitored;
  - The service provider is required to allocate dedicated personnel or engineers that will deal with our internet solution's issues and a dedicated account manager that will handle contract related matters;
  - Provide onsite support if internet solution issues cannot be resolved remotely;
  - Conduct regular tests of failover lines and other internet solution equipment;
  - Conduct regular site visits and meeting to provide feedback on performance;
  - From Monday to Friday between 08:00 to 17:00 FP&M SETA cannot afford any disruption of any internet solution services;

 Any maintenance schedule the SETA must be notified five (5) working days prior to the service. Notification will proceed based on SETA's acceptance.

#### 6. Timeframes

The service will commence from date of signing the SLA and will expire on the 31st March 2018.

#### 8. Terms of Engagement

- 8.1. The successful bidder shall not take more than one (1) month from date of Bid award to render the required service unless otherwise indicated and agreed between the successful Bidder and FP&M SETA.
- 8.2. The Service Provider shall be available for consultation with the FP&M SETA representative.
- 8.3. The Service Provider shall manage as confidential all data, information and insights gained in execution of work for the FP&M SETA.
- 8.4. FP&M SETA retains the right to negotiate with the successful Bidder for partial execution of the proposal.
- 8.5. FP&M SETA retains the right to require the Service Provider to obtain permission in

- writing from the FP&M SETA prior to replacement of individuals proposed for execution of this Bid.
- 8.6. Service Providers to accept professional liability for services rendered, including those rendered under sub-contract to the service provider.

#### **CONDITIONS OF THE TENDER**

#### 9. Contents of Submission

- 9.1. Proposals shall include all relevant information about the Bidder, which is thought appropriate to assist the FP&M SETA to assess its capabilities, capacity, outputs, value adding abilities, competitive advantage, etc.
- 9.2. The proposals presented are to be comprehensive and should describe the methodology to be used in executing the required services. Bidders should also indicate value added services expected to be provided to FP&M SETA.
- 9.3. The proposals presented are to be as comprehensive as possible and FP&M SETA reserves the right to request the Bidder to provide more details.
- 9.4. Bidders shall adhere to the conditions stipulated in the General Conditions of Contract as prescribed by the National Treasury.
- 9.5. Bidders must ensure that the complete bid document is submitted with all additional required information and any other documents that the bidder wishes to supply to substantiate or clarify specific aspects in the proposal.
- 9.6. Failure to submit the bid document and / or any required documentation may result in disqualification.

#### 10. Broad-based Black Economic Empowerment (BBBEE)

- 10.1. In terms of the Preferential Procurement Policy Framework Act (PPPFA), Act 5 of 2000, the 90/10 principle shall be applicable to this bid and points shall be allocated as indicated under functionality. Sound evidence for points claimed must be attached so that points can be allocated.
- 10.2. (Claim BBBEE points on SBD 6.1 and attach original or certified BBBEE certificate for BBBEE points to be allocated)

#### 11. Price and Pricing Structure

- 11.1. Bidders shall indicate the basis on which the services will be charged. In this regard the following information shall be provided:

- 11.5. Prices must include VAT, if it is applicable and all other costs related to the execution of the required services.
- 11.6. The bidder agrees not to change the price with VAT or any other Tax subsequent to submitting the tender. This includes subsequent VAT registration.
- 11.7. Payment will be done as per work done and invoiced there is no 50% upfront payment.
- 11.8. All prices quoted are to be in SA Rand.

#### 12. Oral Presentations

12.1. No oral presentation will be required

#### 13. Compliance with General Conditions of Contract

- 13.1. No alteration, variation or amendment of the Contract (of which this Bid represents the offer) shall be permitted unless otherwise agreed to in writing. Should the prospective provider, in the case of non-compliance, wish to make any amendments to the conditions stipulated by the FP&M SETA in this Bid, then such proposed amendments shall be clearly stipulated by the prospective Bidder and where possible stating the increase or decrease in the cost involved by such proposal. The FP&M SETA reserves the right to reject such submissions.
- 13.2. Misrepresentation of facts will result in disqualification and cancellation of the Contract.

#### 14. Acceptance of Submissions

14.1. No submission shall be deemed to have been accepted, unless and until a formal order has been commissioned and executed. Submissions shall remain open for acceptance by the FP&M SETA for a period of 90 (ninety) days from the date on which they are returnable in terms of this Bid.

#### 15. FP&M SETA Liability

15.1. The FP&M SETA does not bind itself to accept the lowest or any Bid proposal, nor to assign any reason for the rejection of a Bid proposal, nor shall it be responsible for or pay any expenses or losses that may be incurred by the prospective Bidders in the preparation and delivery of its submission.

#### 16. Pricing

16.1. No change in the prices submitted shall be considered after receipt of response to the Bid submission within the 90 days validity

#### 17. Amplification of Submissions

17.1. The FP&M SETA may, after the opening of submissions, call on the prospective Bidder to amplify in writing any matter which is not clear in the prospective Bidder's submission and such amplification shall form part of the original submission. In the event of the prospective Bidder failing to supply such information, the submission will be liable to rejection.

#### 18. Cost of Proposal

18.1. Bidders shall bear all costs associated with the preparation and submission of their proposals, the FP&M SETA will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the Bid.

#### 19. Bid Documents

19.1. This document in its entirety serves as the complete Bid document. Proposals offering only part of the requirements will be rejected. The Bidder is expected to examine all corresponding instructions, forms, terms and specifications contained in this document. Failure to comply with these documents will be at the Bidder's risk and may affect the evaluation of their proposal.

#### 20. Documents Comprising the Proposal

20.1. In preparing the technical and price components of the submissions all references to descriptive material and brochures should be included in the appropriate response paragraph, although material documents themselves may be provided as annexes to the proposal / response. Bidders are requested to focus on the provision of relevant information and to limit the amount of marketing and "boilerplate" material. The successful Bidder's proposal may be incorporated in whole or in part in the final contract. Any information that the Bidder considers proprietary should be marked as such.

#### 21. Information

21.1. Information that the Bidder considers proprietary, if any, should be clearly marked "proprietary" next to the relevant part of the text and it will be treated as such accordingly.

#### 22. Period of Validity

- 22.1. Proposals shall remain valid for ninety (90) days after the date of proposal submission. A proposal valid for a shorter period may be rejected by the FP&M SETA on the grounds that it is non-responsive.
- 22.2. In exceptional circumstances, the FP&M SETA may solicit the Bidder's consent to an extension of the period of validity. The request and the responses thereto shall be made in writing.

#### 23. Format and Signing of Proposals

23.1. The Bidder shall prepare four copies of the proposal, clearly marking each "Original Proposal" and "Copy of Proposal" as appropriate. In the event of any discrepancies

between them, the original shall govern. The four proposals shall be signed by the Bidder or a person or persons duly authorised to bind the Bidder to the contract.

#### 24. Interlineations

24.1. A proposal shall contain no interlineations, erasures, or overwriting except, as necessary to correct errors made by the Bidder, in which case such corrections shall be initiated by the person or persons signing the proposal.

#### 25. Performance Based Agreement

25.1. This is a performance based agreement that shall run from awarding the tender to the successful bidder till the completion of the tender.

#### 26. Payment

26.1. The successful Bidder shall be paid upon submission of an invoice for each transaction of satisfactory work detailed in the scope.

#### 27. Due Diligence

27.1. The FP&M SETA reserve the right to exercise due diligence to submitted tenders.
